- ONE (1) ROW WITHIN THE CENTER OF THE SIDE LAPS SPACED 18" O.C.

ZONE 2

- NOMINAL 60% OF FIELD ROW SPACING
- ONE (1) ROW WITHIN THE CENTER OF THE SIDE LAPS SPACED 18" O.C.
- ONE (1) INTERMEDIATE ROW, WITH FASTENERS SPACED 18" O.C. AND STAGGERED

ZONE 3

- NOMINAL 40% OF FIELD ROW SPACING
- ONE (1) ROW WITHIN THE CENTER OF THE SIDE LAPS SPACED 18" O.C.
- TWO (2) INTERMEDIATE ROWS, WITH FASTENERS SPACED 18" O.C. AND STAGGERED
